

## Echo Company California State Militia 2<sup>nd</sup> Regiment



### **Terms of Membership**

- 1. Enlistment in the California State Militia, 2<sup>nd</sup> Regiment and Echo Company is entirely voluntary and as such the enlistee has the right to resign at any time
- 2. All members are expected to train (FTX) together as a Company at a minimum six (6) times a year. Platoons will train once a month on the first Saturday and the Company will FTX (Field Training Exercise) once a month on the third Sunday of every month. This schedule is subject to changes due to holidays and peculiarities of the calendar.
- 3. Enlistment may be one of two types, active or inactive reserve, and may be changed at any time at the discretion of the enlistee or HQ. Members failing to meet the training standards of CSM may be barred at the discretion of CSM leadership.
- 4. Members who are rostered as inactive reserve are expected to review the notes and lessons presented during the active drill sessions to remain current on the squad/platoon/company training program.
- 5. Members understand that his/her relevant information (phone number and email address) will be furnished to the entire unit to which they are assigned for the purpose of recall/alert.
- 6. ALL members are expected to participate or contact their leadership during a recall.
- 7. In the event of an emergency, disaster, or crisis event all members will be expected to report in as directed in the alert plan of each unit.
- 8. Physical fitness may be self-conducted yet monitored.
- 9. Marksmanship training may be self-conducted yet monitored. Basic Rifle Marksmanship classes are provided. Proficiency and safety in individual weapons systems is a priority; any gross violations will result in disciplinary action.
- 10. Any member choosing to resign from the militia is responsible for returning all unit equipment issued. If said resignation is the result of displeasure or controversy, members pledge to "do no harm" and arbitrate the grievance outside of public domain and among membership only.
- 11. New members (recruits) will be required to complete the "Recruit/Basic" training program prior to participating in more advanced individual or unit training.
- 12. New members will be given an adequate amount of time in which to obtain their basic equipment. A lack of equipment is not an acceptable reason for missing training.
- 13. Training will not be deemed complete until verified by your platoon leader.
- 14. If you are active military, you are precluded from training as an active member and will be considered an associate.
- 15. Members will follow the orders of their chain of command unless such orders are deemed to be a violation of the law, outside of the scope of militia service or in gross violation of any California State Militia Standard Operating Procedure.

As a condition for the participation in events occurring with the California State Militia (CSM), the undersigned hereby releases the California State Militia, its allied parties, related or subsidiary companies and the officers, directors, employees and agents of such entity or organization from liability for any and all property damage, theft, personal injuries or other claims arising from their participation in any events on the premises, including claims that are known and unknown, foreseen and unforeseen, future or contingent. The undersigned shall not now or at any time in the future, directly or indirectly, commence or prosecute any action, suite or other proceeding against the before-mentioned arising out of or related to the actions, causes of action, claims and demands herby waived, released or discharged by the undersigned, legal representatives, heirs, successors, and assigns.

The undersigned acknowledges that the events may be inherently dangerous and could result in injury to the participant, and acknowledging such assumes the full responsibility of any such risk.

The undersigned herby releases the California State Militia, 2<sup>nd</sup> Regiment and Echo Company in accordance with the above release with respect to his or her, the undersigned's, participation in any such events.

This is a full and final release applying to all unknown and unanticipated injuries, deaths or damages arising out of any accident as well as to those now known or disclosed, unknown or un-disclosed, and the undersigned waive all rights or benefits which the undersigned now has or in the future may have under the terms of Section 1542 of the Civil Code of the State of California, which reads:

"A General Release Does Not Extend To The Claims Of Which The Creditor Does Not Know Or Suspect To Exist In His/Her Favor At The Time Of Executing The Release, Which If Known By Him/Her Must Have Materially Affected His/Her Settlement With The Debtor."
